## **Terms and Conditions**

By signing this Terms and Conditions of Entry contract you agree to strictly adhere to the conditions detailed below. This contract is available in alternative formats if required, including in large print and in digital form at http://kittycafe.co.uk/terms-and-conditions. For the purposes of this contract the company is Kitty Cafe Nottingham Ltd., the Premises is 31-37 Friar Lane, Nottingham, NG1 6DD. The Customer is anyone other than employees or contractors of Kitty Cafe entering the Premises. The Child or Children is anyone under the age of 18. The Guardian(s) is/are anyone with responsibility for any Child or Children entering the premises.

## Safety

The following conditions are to ensure the safety of the Customers, the cats, and the staff. Any breach of the terms and conditions stated shall be considered an act of negligence by the Customer or Guardian of Children. Kitty Cafe Nottingham Ltd shall not be held liable should any of these conditions be breached. Any breach may result in temporary or permanent exclusion from the Premises

1. Do not pick up the cats; 2. Do not pull the cats' tails; 3. Do not wake a sleeping cat; 4. Do not feed the cats; 5. Do not push the cats off chairs, sofas, tables, or any object; 6. Do not touch the cats with your feet; 7. Do not hold the cats down or attempt to force them to remain in any area or position; 8. Do not attempt to corner or trap the cats in any area or position or chase a cat; 9. Do not run in the Premises; 10. Do not make loud noises on the Premises; 11. Do not carry hot drinks around the Premises; 12. Do not use electronic cigarettes or vaping devices on the Premises; 13. Do not play your own music within the Premises; 14. Laser pens and torches are strictly prohibited; 15. Cat toys or any other equipment for the purpose of interacting with the cats is strictly limited to that which is provided by the staff; 16.Keep mobile communication devices (including, but not limited to, mobile telephones, tablet PCs, computers, and laptops) on silent mode or muted; 17. If you are allergic or intolerant to any of the following or suspect that you may be so, you must ensure you have sought advice from a relevant medical practitioner, such as a GP, prior to entering the Premises: • Cats; • Latex; • Sodium Bentonite; • Silica; • Anigene; • Tetrachlorvinphos; • Permethrin; • Carbaryl; • Propoxur. 18. All media taken within the premises remain property of the Kitty Cafe Nottingham and must be provided upon request to the cafe, any use of media taken within the Cafe used on any platform must be removed if requested to do so by Kitty Cafe Nottingham Ltd. Kitty Cafe Nottingham Ltd agrees to personal use of pictures in a way that does not challenge the ethos and public opinion of Kitty Cafe Nottingham Ltd 19. Customers enter at their own risk . 20. Liability is not accepted for damage or loss to any property bought into the café by a customer 20. Customers accept that due to the nature of the premises that there is an element of risk to person and property and by entering agree that this is an acceptable risk.

## Children

Children of any age are permitted on the Premises, however the following additional terms and conditions apply to the Guardian(s). 1. Children must remain under the supervision of the Guardian(s) at all times and must comply with the rules stated above - this is the sole responsibility of the Guardian(s); 2. The Guardian(s) must ensure that the Child or Children under the supervision of the Guardian(s) has no allergies or intolerance to the following: • Cat; • Latex; • Sodium Bentonite; • Silica; • Anigene; • Tetrachlorvinphos; • Permethrin; • Carbaryl; • Propoxur. 3. The Guardian(s) must ensure that any petting or handling of the cats in any way must be slow, gentle and carried out with due caution. If the Guardian is unsure of how Children should interact with the cats in a safe manner then the cats must not be touched or interacted with in any way without first consulting a member of staff. 4. Parents and Guardians accept full responsibility of their child at all times and enter at their own risk

## **Pregnant Women**

Kitty Cafe advises against entry to the Premises during pregnancy. However, should the Customer wish to visit during pregnancy Kitty Cafe requires the Customer to seek advice from a relevant medical practitioner, such as a GP, prior to entering the Premises. The customer enters at their own risk.
